Chapter 1

Safety Guidelines

To avoid personal injury and property damage, carefully follow all the safety steps listed below when accessing your system or handling the components.

1-1 ESD Safety Guidelines

Electrostatic Discharge (ESD) can damage electronic components. To prevent damage to your system, it is important to handle it very carefully. The following measures are generally sufficient to protect your equipment from ESD.

- Use a grounded wrist strap designed to prevent static discharge.
- Touch a grounded metal object before removing a component from the antistatic bag.
- Handle the backplane by its edges only; do not touch its components, peripheral chips, memory modules or gold contacts.
- When handling chips or modules, avoid touching their pins.
- Put the card and peripherals back into their antistatic bags when not in use.

1-2 General Safety Guidelines

- Always disconnect power cables before installing or removing any components from the computer, including the backplane.
- Disconnect the power cable before installing or removing any cables from the backplane.
- Make sure that the backplane is securely and properly installed on the motherboard to prevent damage to the system due to power shortage.

Connectors and Pin Definitions

2-1 Front Connectors




Figure 2-1: Front Connectors

The BPN-SAS-816T-A2 backplanes features the following front connectors:

Front Connectors

- 1. Power Connector: (4-pin) JP10.
- 2. SATA Connector #0: J5, connect to cable.
- 3. SATA Connector #1: J6, connect to cable.
- 4. SAS#0 Connector, J1.
- 5. SAS#1 Connector, J2.

2-2 Front Connector and Pin Definitions

1. Power Connector

The 4-pin connector designated JP10 provides power to the backplane. See the table on the right for pin definitions.

2. - 3. SATA Connectors

The SATA connectors are used to connect the SATA cables. The two connectors are designated #0 and #1.

4. - 5. SAS Connectors

The SAS connectors are used to connect the hard drives. The two connectors are designated SAS#0 and SAS#1. Each connector is compatible with SATA and SAS drives.
